# POLICY FOR BANNERS DISPLAYED ON BOROUGH BANNER POLES AT 21 EAST MAIN STREET

#### 1. BACKGROUND:

- In the past various community organizations hung banners across Main Street in Mount Joy Borough.
- The banners were hung between PPL utility poles
- PPL notified the Borough that banners could no longer be hung on PPL utility poles.
- As part of the Mount Joy Rail Enhancements Project, Phase 1, banner poles were installed at the Borough office, 21 East Main Street, Mount Joy.
- Main Street, State Route 230, is State road and PennDOT regulations for hanging banners must be followed:
  - Borough Council must adopt a resolution and submit an original, signed copy to PennDOT District 8 Traffic Unit.
  - The resolution will provide the location, width, length and suspension height from the roadway of the banner.
  - o The resolution will also provide the name of the event, and dates of display.
  - The permit request and resolution must be received by the PennDOT District 8
    Traffic Unit at least four weeks prior to the banner being hung.
  - Banners should not be hung for more than two weeks prior to the event and should be removed as soon as practical after the event.
  - No more than 20% of message may relate to naming or advertising a commercial product, enterprise, business or company regardless of whether they are sponsoring the event of banner installation.

#### 2. POLICY

#### Requests

- Requests to hang banners including but not limited to those of a personal, commercial or political nature will not be considered.
- Requests for banners to be hung on the Mount Joy Borough banner poles must be submitted on the form provided by the Borough to the Chief of Police.
- A Certificate of Insurance naming the Borough as the additional insured must be provided.
- Receipt of PennDOT permit could take up to 12 weeks from date of submission.
  Submission of requests with insufficient and/or incorrect information may cause further delay. The Borough assumes no responsibility for delays caused by a longer response time from PennDOT.
- Requests will be considered on a first come-first served basis.
- Banner Specifications- Please see attachment "A" for banner specification.
- Only Borough Staff of designee(s) will be permitted to install and remove banners.
- The Borough reserves the right to remove the banner as deemed necessary.
- The Borough shall not be responsible for any damage that may occur to Banner by weather or vandalism.
- This policy applies as it pertains to employees of Mount Joy Borough.
- This policy applies as it pertains to any person, persons or organizations requesting a banner to be hung on the Mount Joy Borough banner poles.

#### 3. RESPONSIBILITY

• It shall be the responsibility of all individuals, groups and organizations to comply with this policy.

#### 4. DISTRIBUTION
