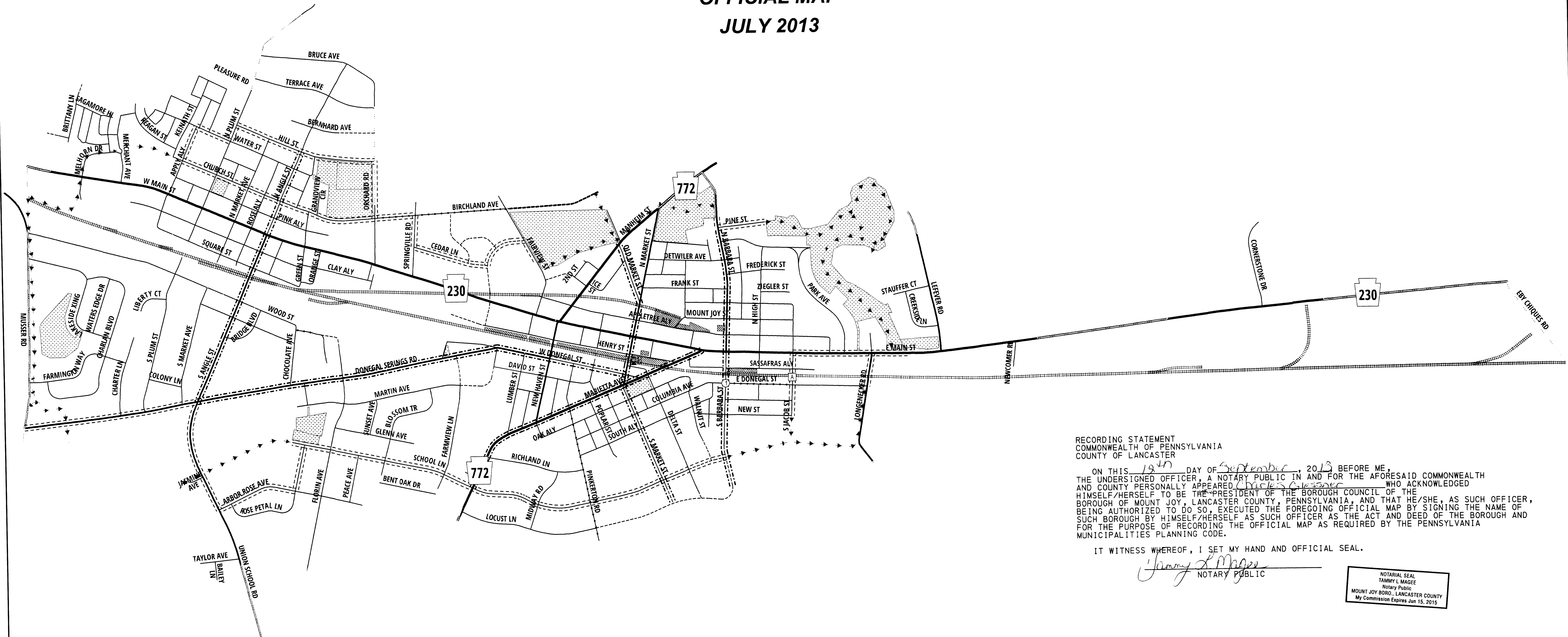




MOUNT JOY BOROUGH OFFICIAL MAP JULY 2013

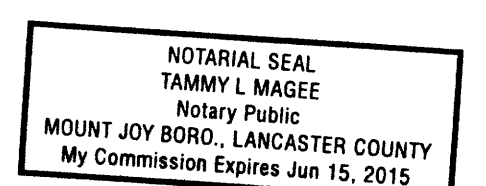


RECORDING STATEMENT
