ORDINANCE NO.	1-15

AN ORDINANCE TO AMEND THE MOUNT JOY BOROUGH CODE OF ORDINANCES, CHAPTER 255, VEHICLES AND TRAFFIC, TO REVISE PARKING REGULATIONS.

BE AND IT IS HEREBY ORDAINED AND ENACTED by Borough Council of the Borough of Mount Joy, Lancaster County, Pennsylvania, as follows:

Section 1. The Code of Ordinances of the Borough of Mount Joy, Chapter 255, Vehicles and Traffic, Section 255-63, Parking Prohibited at All Times in Certain Locations, shall be amended by deleting the following parking prohibitions:

East Main Street	North	A point 126 inches east of Coal Alley and a point 202 inches east of Coal Alley.
East Main Street	North	North Market Street to the first metered space.
East Main Street	South	First Federal S&L driveway and a point 25 feet from the driveway.
East Main Street	South	A point 48 inches east of South Barbara Street to a point 72 inches east on East Main Street.
Fairview Street	East	Main Street and the railroad crossing.
Manheim Street	North	Old Market Street to the railroad.
Manheim Street	South	Ice Alley and a point 50 feet east.
Manheim Street	South	North Barbara Street and Old Market Street.
Manheim Street	South	West Main Street and Ice Alley.
Marietta Avenue	South	Main Street and a point 122 feet south.

Section 2. The Code of Ordinances of the Borough of Mount Joy, Chapter 255, Vehicles and Traffic, Section 255-63, Parking Prohibited at All Times in Certain Locations, shall be amended by inserting the following parking prohibitions in alphabetical order:

Hill Street	North	Orchard Road and a point 435 feet west of Orchard Road.

Manheim Street	Both	West Main Street to municipal boundary.

Section 3. The Code of Ordinances of the Borough of Mount Joy, Chapter 255, Vehicles and Traffic, Section 255-64, Parking Prohibited During Certain Days and Hours, shall be amended to provide as follows:

Parking shall be prohibited in the following locations at all times on the days and between the hours indicated in the Section, as follows:

Section 5. The Code of Ordinances of the Borough of Mount Joy, Chapter 255, Vehicles and Traffic, Section 255-66, Parking Time Limited During Certain Days and Hours, shall be amended to add the following parking limitations in alphabetical order:

Section 6. The Code of Ordinances of the Borough of Mount Joy, Chapter 255, Vehicles and Traffic, Section 255-67, Special Purpose Parking Zones, shall be amended to delete all special purpose parking zones on East Main Street, Marietta Avenue, New Haven Street, North Barbara Street, Pink Alley, South Barbara Street, South Jacob Street, and West Main Street.

<u>Section 7.</u> The Code of Ordinances of the Borough of Mount Joy, Chapter 255, Vehicles and Traffic, Section 255-69, Angle Parking, to delete the following regulation:

West Donegal Street	North	200 feet west of intersection to dead end

<u>Section 8.</u> All other sections, parts and provisions of the Code of Ordinances of the Borough of Mount Joy shall remain in full force and effect as previously enacted and amended.

Section 9. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.

Section 10. This Ordinance shall take effect and be in force from and after its enactment as provided by law.
